# Dr. PC Markanda Chair on ADR

Late Advocate Dr. P.C. Markanda was one of the leading arbitration lawyers in India. He was popularly known as the Father of Indian Arbitration. His career spanning several decades saw him contributing immensely to the working and jurisprudence of arbitration in the country. Starting off as a civil engineer, he went on to earn a Doctor of Laws (LLD), and wrote several books on the law of arbitration, partnership, building and engineering contracts, for laypersons and experts. Dr. Markanda was also a honoured recipient of a posthumous degree of LL.D. (post-doctoral) from Rajiv Gandhi National University of Law (RGNUL). To carry forward his legacy and vision, RGNUL has set up Dr. P.C. Markanda Chair on ADR.

The objective of the Chair is to set up RGNUL as a hub of Arbitration and to render training and technical assistance by way of setting up training institutes for Arbitration and Mediation, to conduct meaningful research in the areas of ADR and provide consultancy by way of introducing legal start-ups and collaborations in the country and further it aims to impart basic education by way of initiating new degree, diploma and certificate courses by uplifting the core principles and ethics behind ADR.





## Previous Editions

The **Inaugural** RGNUL National Negotiation Competition was organized by CADR, RGNUL and was held online from October 8–10, 2021. Shardul Amarchand Mangaldas acted as the Chief Knowledge Partner, with CAMP as Supporting Partner, Justice Kuldip Prakash Bhandari Foundation, Chandigarh as Knowledge Partner, and SCC Online as Media Partner. The three-day event attracted 34 teams from premier law universities.

The **Second Edition** of the Competition took place physically from November 12–14, 2022, organized by CADR, RGNUL, and the Dr. P.C. Markanda Chair on ADR, RGNUL, Punjab. Knowledge partners and sponsors included Shardul Amarchand Mangaldas, Justice Kuldip Prakash Bhandari, and the Indian Dispute Resolution Centre. Media partners were Live Law, Lawoctopus, and Latest Laws, while Young Negotiators Club (YNC) India and Probono Club RGNUL served as Supporting Partners.

The **Third Edition** of the RGNUL National Negotiation Competition was hosted by the Centre from November 3–5, 2023. ## FORMAT

The **5th NegComp** will be held in an **online mode**.

There shall be two preliminary rounds followed by quarter finals, semi-finals, and finals. The two-member Negotiating Team will comprise of a client and a counsel who will mandatorily have to play both roles atleast once during preliminary rounds.

Universities interested in sending more than one team are requested to express their intention by reaching out to the organizing committee. It should be noted that the allocation of slots to any university will be a decision made solely by CADR-RGNUL, and shall be final and binding.

Any student enrolled in Undergraduate or Postgraduate Law degree programme in any University recognised by the Bar Council of India as on 1st September 2025, is eligible to participate.

Each University must be represented by two students, i.e. one Client and one Counsel. The composition of the team will not be permitted to change once the same has been communicated to the Organising Committee.

The Registration Fee for the competition is **INR 6500/-** per team (exclusive of GST). The fee is non-refundable.
